Some information that we received was that we are getting low enrollment. 15 out of every 100 students did not enroll and one of the biggest issue is because of the new SIS system.

-Administration then took the initiative on creating the Boom Festival that actually happened yesterday. It was really fun and I think many students enjoyed it and we had a great outcome.

-I met with Vice President Ruben Arenas to get some guidance on how we can get a piece of the share of the funds that are being used.
